**CHANGE IN DESTIN FIRE CONTROL DISTRICT
MILLAGE CAP TO 3.75 MILLS**

To operate and maintain the Destin Fire Control District's current Facilities, Fire Rescue, Advanced Life Support and Beach Rescue Services for the citizens of the District, shall the District be allowed to change the millage cap from the current rate of 1.0 mills, approved in 1971, to 3.75 mills as authorized by Chapter 191, Florida Statute. Your elected Commissioners set the millage rate annually, which determines the rate you pay, during publically open budgeting processes.

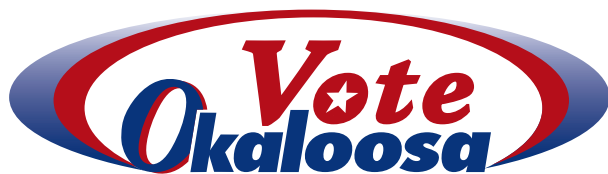

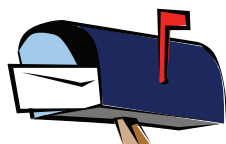

**Be sure to bring a current and valid ID that includes your picture and signature for precinct and early voting! If the picture ID does not contain your signature, an additional ID that includes your signature shall be required. Approved forms of ID are: Florida Driver's License, Florida ID Card issued by the Department of Highway Safety & Motor Vehicles, Military ID, Current U.S. Passport, Debit/Credit Cards, Student ID, Retirement Center ID, Neighborhood Association ID, and Public Assistance ID.
